Family History Tour to Ireland Almost Full

The Scully-Greene-Dunn Family Association, through the travel agency of our cousin Rick Synnott, has arranged a Family History Tour of Ireland from July 21 to July 31, 1999. The tour will feature many of the attractions of Ireland, as well as a visit to the region of Ireland where our family lived (County Laois) prior to their emigration to the United States. Stops on the trip include visits to the Royal Tara China Factory, Cliffs of Moher, Trinity College, St. Patrick's Cathedral, Waterford Crystal Factory, the Rock of Cashel, Kilkenny Castle, Kylemore Abbey, Blarney Castle, and knitwear/woolen outlets. The trip includes full Irish Breakfast daily and 8 hotel dinners. Entertainment for one night of the trip will be at Bru Boru, a banqueting facility that provides the best traditional entertainment in Ireland. During the 10 day trip, participants will stay at the following five hotels: The Imperial Hotel in Galway, the Stakis Dublin Hotel in Dublin, The Killeslin Hotel in Portlaoise, the Dundrum House Hotel in Tipperary, and the Killarney Towers Hotel in Killarney. All of these hotels offer first class and superior first class accommodations with private bath/shower. Sightseeing throughout Ireland will be by Deluxe Touring Motorcoach.

As of the time this newsletter was mailed, there are only a few seats open for this tour. Anyone interested in attending should contact A&S Travel Agency at 203-755-5548. The cost of the trip is \$1,949.00.
